Thomas Arthur Fessenden of Lancaster, PA, formerly of Germantown, MD passed away on Saturday, June 15, 2024 at Trillium Place by Tandem Living. Born in Washington, DC, he was the son of the late Robert Arthur Fessenden and Ceora Mary (Chance) Fessenden.

Thomas graduated from Bethesda Chevy Chase High School, Bethesda, MD and the University of MD, College Park, MD. After graduation, he joined the U.S. Army and was deployed to Thailand and Okinawa. Soon after his honorable discharge, Thomas started his 24 years of career in fire service with the Montgomery County, MD, Department of Fire Rescue Services, retiring in July 1996 after attaining the rank of Battalion Chief.

Thomas was a life member of the Bethesda Chevy Chase Rescue Squad, Bethesda, MD a member of the Mason Dixon Chapter of the ARS, an associate member of the Potomac Valley Chapter of the ARS, and a member of the BCC Rescue Squad Alumni Association.

After moving to Lancaster, Thomas joined the Union Fire Company Number One, established in 1760. His interests included gardening, plant propagation, WWII history and spending time with his family, especially his grandchildren.

He was the loving husband of Anne Lynn (Rankin) Hill-Fessenden of

Lancaster, brother of Mary Fessenden Gilmore of Avon Lake, OH, stepfather of Jennifer Hill Reinert (Michael) of York, PA, Carolyn Hill Consoli (Angelo, Jr.) Upper Marlboro, MD, grandfather of Angelo Consoli III, Nicolas Consoli, Callie Ruffatto, Katherine Consoli and Steven Ruffatto, Jr. He is also survived by two nieces, Kristine Gilmore Brott and Tracey Gilmore Matejka and their children: Cole Brott, Paul Brott, Kelly Brott, Halle Matejka and Moly Matejka.
