Thomas M. Hampton, 70, of Lancaster died surrounded by his family on Monday, November 5, 2012 at The Lancaster General Hospital. Born in Lancaster he was the son of the late Harold and Blanche Cramer Hampton. He celebrated 50 years of marriage with his wife Lucinda Englert Hampton.

Tom graduated from Lancaster-Strasburg High School. He retired in 1995 from Armstrong World Industries where he was a Millwright in the Floor Plant Division for 35 years. After his retirement he worked part-time for Lancaster County as a Special Court Constable.

He was baptized at St. Paul's Methodist Church. Tom was a member of The Hamilton Club. A vintner, he established Tucquan Vineyard and Winery in Holtwood where he started growing grapes in 1968 and began bottling his wine in 1978. He loved traveling and the outdoors especially hunting, trout fishing including many fishing trips and golf outings. Tom enjoyed time at Drennen Camp in Sullivan County, camping on Assateague Island, catching up with the L.S. Group and spending time at Dewey Beach with his family.

In addition to his wife Cindy, he is survived by his sons Thomas Bradford husband of Kristine Costello Hampton, Brownstown, Jason husband of Jennifer Showalter Hampton, Elizabethtown, his sister Sharon wife of Robert Shapack, Clearwater, FL and his four grandchildren; Alex Hampton, Ava

Hampton, Maia Hampton and Madalyn Hampton.
